Using the Chart Below

1. There are two designations for local competitions: closed and open. A competition is closed when entries are limited to those who live, work, or attend school full time in a specific License Area. Competitions listed as “Open Statewide” are open to any eligible candidate in the state.
2. “OT” means Outstanding Teen and indicates that a local holds an Outstanding Teen Competition.
3. Competition Dates are “confirmed,” which means the date is definite, “target” meaning that this is the date the program hopes to hold its competition, and “TBD” means that the date is to be determined.
4. The latest date for a local to hold its competition, leading to Miss California 2022, is Sunday March 13, 2022. Exceptions for later dates may be granted if the reasons are compelling.
5. When two titles are listed for an event, such as “Miss Anaheim Hills and Miss Canyon Hills,” this means that two winners are selected from a single group of candidates.
6. License Areas are subject to change during the term of this License Agreement, based on local needs/requests and MCO needs. Rarely does a change cause a license area to be more restrictive.
